### Southeast Iowa Sprint Series Rules and Regulations

I do agree by signing this Sprint Invaders Association Membership form, that I will abide by all the rules and regulations set forth by the Association including, but not limited to the following:

1. I have, or will have, familiarized myself with all the Sprint Invaders Association rules and regulations, including car specifications and safety rules, and I specifically agree to abide by all the Sprint Invaders Association rules.
2. I agree that the driver shall be the sole spokesperson for the team, the car owner, and any member of the crew in all matters pertaining to competition at any Sprint Invaders Association sponsored event.
3. I understand that the burden of proof regarding compliance with all Association rules and regulations falls upon the race team itself.
4. I agree to appropriately use all required stickers, decals and patches, and I understand that failure to do so may result in loss of eligibility of awards for the event (members only).
5. I agree that all decisions of Sprint Invaders Association race officials or track officials regarding the interpretation and application of the Sprint Invaders rules, and the scoring of positions shall be non-litigable. I further attest and agree that I will not initiate any type of legal action against the Sprint Invaders Association or a Sprint Invaders Association promoter or board member to challenge such decisions, to seek monetary damages, to see injunctive relief or to seek any other kind of legal remedy. I understand that if I pursue any such legal action, which violates this provision, then I expressly agree to reimburse the Sprint Invaders Association, promoter or board member for all attorney's fees and costs in defending against such legal action.
6. I also agree to release all advertising and promotional rights to my name, car and likeness to the Sprint Invaders Association and its sponsors.
7. I understand and agree that points are awarded to both the registered driver (member) and registered car owner (member) and that awards and money earned will be paid to the car owner unless otherwise specified by the presenting organization.

I further understand that there is no express or implied warranty of safety resulting from publication or compliance with the Sprint Invaders Association rules and that they are intended as a guide for the conduct of the sport and are in no way a guarantee against injury or death to participants, spectators or others.
